私隱政策

以下個人資料私隱聲明乃根據香港《個人資料(私隱)條例》(「條例」)而提供,是關於不時向人工智能開放式基金型公司 (「本公司」)或其聯屬公司提供的個人資料或資訊(「資料」)。本公司致力遵守條例的規定,嚴格保護任何向我們提供個人資料之人士的私隱。就此,本公司指示屬下職員遵守有關保安及保密的嚴格內部標準。

A. 收集

- 1. 申請人須不時就不同事項(例如開立賬戶或繼續運作、向申請人提供服務或遵從法律或監管或其他當局所頒布任何指引)而向人工智能開放式基金型公司提供資料。
- 2. 可收集資料的種類包括(但不限於)姓名及地址、職業、聯絡資料、出生日期及國家、國籍、身份證、社會保障或全國保險號碼、稅務居留國家、稅務參考號碼或護照號碼及財政狀況詳情。
- 3. 若未能提供該等資料,有可能會導致人工智能開放式基金型公司無法為申請人開立賬戶或繼續向申請人提供服務,又或無法遵從法律或監管或其他當局所頒布的任何指引及守則。
- 4. 在延續申請人與人工智能開放式基金型公司的關係的日常業務過程中亦會向申請人收集資料, 例如在申請人開立賬戶、簽發支票、轉賬、進行交易、出席研討會/活動、參與網上活動, 或與人工智能開放式基金型公司進行一般口頭或書面通訊。
- 5. 人工智能開放式基金型公司可能從網站上收集額外資料, 該等資料包括但不限於:
- 5.1 瀏覽者個人電腦的訊息處理機位址、提出查詢所在國家、曾經瀏覽之網頁、瀏覽網頁之時間及瀏覽器之類型;
- 5.2 瀏覽者的若干個人資料(例如瀏覽者之姓名、年齡、性別、職業等)、聯絡資料、客戶識別資料、電子加密處理保安密碼、有關所持由人工智能開放式基金型公司發售或分銷之基金的資料、瀏覽者是否希望收到資訊及希望收到資訊的類型。

除任何保安密碼外, 於任何人工智能開放式基金型公司網站所收集之個人資料皆不會被電子加密處理。

人工智能開放式基金型公司或人工智能開放式基金型公司的第三者合作夥伴可能會利用軟件工具或Cookies以收集瀏覽者瀏覽網站的活動。被收集的資訊可能會經由人工智能開放式基金型公司或代理人或任何第三者服務供應商處理。請瀏覽有關人工智能開放式基金型公司Cookies政策的詳情。

B. 目的及用途

- 1. 使用資料之目的將視乎申請人與人工智能開放式基金型公司的關係性質而異。人工智能開放式基金型公司擬就下列任何或全部目的而使用其資料(包括申請人所提供的任何第三者資料):
 - 1.1 辦理於本公司開立賬戶的申請(包括確認及查證申請人身份):
 - 1.2 申請人賬戶的日常運作及所獲提供服務;
 - 1.3 任何有關人工智能開放式基金型公司所提供產品與服務的行政管理的目的;
 - 1.4 為客戶研究、設計及推售金融、投資服務或相關產品;

- 1.5 符合適用於在香港或其他地區的人工智能開放式基金型公司的任何法律或規例、守則、 指引或人工智能開放式基金型公司內部合規政策下的披露、申報及合規規定(包括但不限於稅 務申報):
 - 1.6 以下服務及產品的推廣與直接促銷(惟申請人有權反對該項用途):
 - 1.6.1 財務策劃及投資、財富管理及相關服務及產品;
 - 1.6.2 金融、投資及教育研討會及論壇:
- 1.6.3 人工智能開放式基金型公司及/或任何人工智能開放式基金型公司實體的業務之全部或任何重大部分的任何受讓人所提供的其他金融服務及產品;

1.7 使:

- 1.7.1 任何人工智能開放式基金型公司實際或建議的承讓人:
- 1.7.2 任何人工智能開放式基金型公司對於申請人及/或「綜合理財賬戶」的權利或義務的實際或建議的參與者、次參與者或受讓人;及/或
- 1.7.3 任何人工智能開放式基金型公司對於申請人及/或「綜合理財賬戶」的義務的更替方, 能夠評核, 執行及/或完成任何出讓、參與、次參與、轉讓、約務更替或其他類似安排的有關交易: 及
 - 1.8 任何其他與上述直接相關的目的。
- 2. 申請人有權反對將其資料用作第1.6段所載直接促銷目的。申請人若提出要求,人工智能開放式基金型公司將停止使用其資料作直接促銷用途,並不會就此收取費用。

C. 直接促銷:

- 1. 人工智能開放式基金型公司擬將所收集的資料用作直接促銷用途,但除非已收到閣下的同意(當中包括表明不反對所擬定之用途),否則不會使用資料作直接促銷用途。
- 2. 此外,人工智能開放式基金型公司擬將所收集的資料提供予任何人工智能開放式基金型公司實體的業務之全部或任何重大部分的所有或任何受讓人(「受讓人」)、服務供應商及相關第三者(包括顧問)(連同受讓人統稱「有關各方」)供其用作直接促銷用途。然而,除非已收到閣下的同意(當中包括表明不反對所擬定之提供),否則不會提供資料予有關各方作直接促銷用途。
- 3. 人工智能開放式基金型公司有意使用所收集的資料(包括但不限於閣下的姓名及聯絡資料 (例如電話號碼、電郵地址及/或通訊地址)),或將之提供予所有或任何有關各方,以供其透過 各種通訊方式(例如直郵函件、電郵、電話、短訊及小冊子)作以下直接促銷用途:
- 3.1 人工智能開放式基金型公司及/或受讓人的財務策劃及投資、財富管理及相關服務及產品,及人工智能開放式基金型公司及/或受讓人所提供的金融、投資及教育研討會及論壇或其他金融服務及產品;及
 - 3.2 人工智能開放式基金型公司及/或受讓人的新產品及服務推售及其他推廣優惠。

D. 保留及查閱

- 1. 所收集的資料可於適用法律規定期間或為達致上述目的所需期間予以保留。
- 2. 人工智能開放式基金型公司所持有關於申請人的資料將會保密,人工智能開放式基金型公司將會採取一切合理措施,以確保資料保管妥善,而不會在未獲授權情況下被查閱、遺失、披

露及銷毀。不論在香港境內或境外,本公司可為上文「目的及用途」及「直接促銷」兩節所載目的而向以下各方提供該等資訊:

- 2.1 本公司的最終控股公司、其附屬機構、代表辦事處、聯營公司及/或聯屬公司:
- 2.2 本公司的服務供應商(包括受託人、投資經理、過戶登記處、轉讓代理人、保管人、行政服務代理人及人工智能開放式基金型公司所發售每種產品的核數師):
- 2.3 任何就人工智能開放式基金型公司的業務運作而向人工智能開放式基金型公司提供行政管理、研究、設計、推售、數碼或電訊、結算及交收或其他服務的代理人、承辦商、分辦商、顧問、保險公司或第三者服務供應商;
 - 2.4 本公司僱員、高級職員及董事;
- 2.5 任何根據法律或規例或因監管機構要求而有權索取資訊的一方(包括但不限於任何地方或外國政府、稅務或監管當局或司法管轄權法院);
- 2.6 人工智能開放式基金型公司為上文「目的及用途」一節第1.6段所載目的, 就外判或其他服務而聘用的聯屬或非聯屬供應商及其他外間服務供應商(包括但不限於印刷公司、郵遞公司、數碼或電訊公司、資訊科技公司、資料儲存及基建公司、雲端服務供應商、資料處理公司及儲存公司): 及
- 2.7 任何人工智能開放式基金型公司實際或建議的承讓人、任何人工智能開放式基金型公司對於申請人及/或「綜合理財賬戶」的權利或義務的實際或建議的參與者、次參與者或受讓人,及/或任何人工智能開放式基金型公司對於申請人及/或「綜合理財賬戶」的義務的更替方。

根據本公司的政策,只有需要使用該等個人資料,並已獲指示妥善處理該等資料及遵守保密原則的人士,方可查閱該等資料。網上交易客戶所用的保安密碼會經過電子加密處理。

- 3. 請注意,轉移至香港境外的資料可能會受較低水平的保障及/或可能不受香港任何有關銀行資料保密制度、客戶資料保密制度或資料保障制度的法律之保障。
- 4. 根據條例, 申請人有權:
 - 4.1 查核人工智能開放式基金型公司是否持有關於申請人的資料,以及查閱該等資料;
 - 4.2 要求人工智能開放式基金型公司更正任何有關申請人而不準確的資料:
- 4.3 確定人工智能開放式基金型公司對資料的政策和慣例, 並獲知會人工智能開放式基金型公司所持有資料的種類; 及
- 4.4 反對將資料用於直接促銷, 經申請人向人工智能開放式基金型公司提出反對後, 人工智能開放式基金型公司不得將其資料用於直接促銷。

根據上述條例的條款,本公司有權就處理任何查閱資料的要求徵收合理費用。

本聲明一概不會限制您在上述條例下所享有的權利。

Privacy Statement

The following Personal Data Privacy Statement is provided to you pursuant to the Personal Data (Privacy) Ordinance of Hong Kong ("Ordinance") in connection with your dealings with, and provision of personal data or information ("Data") to, AI OFC or its affiliates from time to time. AI OFC is fully committed to protecting the privacy interests of individuals who provide us with information about themselves and to comply with the requirements of the Ordinance. In doing so, AI OFC instructs its staff to comply with the strict internal standards of security and confidentiality.

A. Collection:

- 1. From time to time, it is necessary for you to supply Al OFC with Data in connection with various matters such as account opening or continuations, provision of services to you or compliance with any laws or guidelines issued by regulatory or other authorities.
- 2. The kinds of Data that may be collected includes, but is not limited to, name and address, occupation, contact details, date and country of birth, nationality, identity card, social security or national insurance numbers, country of tax residence, tax reference numbers or passport numbers, and details of financial status.
- 3. Failure to supply such Data may result in Al OFC being unable to open an account or continue to provide services to you or unable to comply with any laws or regulations or guidelines and codes issued by regulatory or other authorities.
- 4. It is also the case that Data is collected from you in the ordinary course of the continuation of your relationship with AI OFC, for example, when you open an account, write cheques, transfer funds, effect transactions, attend seminar/events, participate in online activities or generally communicate verbally or in writing with AI OFC.
- 5. Additional Data may also be collected at Al OFC's websites which include, but is not limited to:
- 5.1 the IP address of the visitor's personal computer, the country from which the inquiry is made, the pages visited, the time at which a visit is made and the browser type;
- 5.2 certain personal details of the visitor(these may for instance include his/her name, age, sex, profession), client identification details, electronically encrypted security passcodes, information regarding holdings in any funds offered or distributed by Al OFC. Whether the visitor wishes to receive information and, if so, what kind of information.

Apart from any security passcode, the Data collected at any Al OFC website is not electronically encrypted.

We or our third-party partners may use software tools or 'cookies' to gather information about site visitors' browsing activities. The information collected may be processed by us, our agents or any other third parties which provide services to Al OFC. Please visit our Cookies Policy for further details.

B. Purpose and use:

- 1. The purposes for which Data may be used will vary depending on the nature of your relationship with AI OFC. AI OFC intends to use your Data (including any third party Data provided by you) for any or all of the following purposes:
- 1.1 the processing of an application for an account with Al OFC including confirming and verifying your identity;
 - 1.2 the daily operation of your account and the services to be provided to you;
- 1.3 any purpose related to the administration of the products and services offered by Al OFC:
- 1.4 researching, designing and launching financial, investment services or related products for clients;
- 1.5 meeting the disclosure, reporting and compliance requirements (including but not limited to tax reporting) under any laws or regulations, codes, guidelines or internal AI OFC compliance policies applicable to AI OFC in Hong Kong or elsewhere;
- 1.6 promoting and direct marketing of the following services and products subject to your right to object to such use:
- 1.6.1 financial planning and investment, wealth management and related services and products;
 - 1.6.2 financial, investment and educational seminars and forums;
- 1.6.3 other financial services and products offered by AI OFC and/or any transferee of a whole or any substantial part of business of any AI OFC entity;
 - 1.7 enabling:
 - 1.7.1 any actual or proposed assignee(s) of AI OFC;
- 1.7.2 any actual or proposed participant(s), subparticipant(s) or transferee(s) of Al OFC's rights or obligations with respect to you and/or the MasterAccount; and/or
- 1.7.3 any person(s) in whose favour Al OFC's obligations with respect to you and/or the MasterAccount are, or are to be, novated, to evaluate, execute and/or complete the transaction(s) intended to be the subject of any assignment, participation, subparticipation, transfer, novation or other similar arrangement; and
 - 1.8 any other purpose directly related to any of the above.
- 2. You have the right to object to the use of your Data for direct marketing purposes as set out in paragraph 1.6 above. Al OFC will cease to use your Data for direct marketing purposes without charge if you so request.

C. Direct Marketing:

1. Al OFC intends to use the Data collected for direct marketing but may not so use the Data unless your consent (which includes an indication of no objection to the intended use) is received.

- 2. Furthermore, AI OFC intends to provide the Data collected to all or any of the transferees of a whole or any substantial part of business of any AI OFC entity (the "Transferees"), service providers and related third parties (including consultants) (together with the Transferees, the "Parties") for use by them in direct marketing. However, the Data may not be so provided unless your consent (which includes an indication of no objection to the intended provision) is received.
- 3. Al OFC would like to use the Data collected, including but not limited to your name and contact details (such as telephone number, email address and/or correspondence address), or provide the same to all or any of the Parties for the Parties' use, for the following direct marketing purposes through various communication means such as direct-mail, email, telephone, SMS and brochures:
- 3.1 Al OFC's and/or the Transferees' financial planning and investment, wealth management and related services and products, financial, investment and educational seminars and forums or other financial services and products offered by Al OFC and/or the Transferees; and
- 3.2 Al OFC's and/or the Transferees' new product and service launch and other promotional offers.

D. Retention and Access:

- 1. The Data collected may be maintained for such period of time required under applicable law and as otherwise needed to fulfil the purposes set out above.
- 2. Data held by AI OFC relating to you will be kept confidential and AI OFC will take all reasonable measures to ensure that Data is kept secure against unauthorised access, loss, disclosure and destruction. AI OFC may provide such information to the following parties, whether inside or outside of Hong Kong, for the purposes set out in the "Purpose and Use" and "Direct Marketing" sections above:
- 2.1 the ultimate holding company of AI OFC, its subsidiaries, representative offices, associated companies and/or affiliates;
- 2.2 the service providers of AI OFC including the trustee, investment manager, registrar, transfer agent, the custodian, administrative service agent, and the auditor of each product offered by AI OFC;
- 2.3 any agent, contractor, subcontractor, consultant, insurer, or third party service provider who provides administrative, research, design, launch, digital or telecommunication, clearing and settlement or other services to AI OFC in connection with the operation of its business;
 - 2.4 the employees, officers, directors of AI OFC;
- 2.5 any party (including but not limited to, any local or foreign governmental, tax or regulatory Authority, or court of competent jurisdiction) entitled thereto by law or regulation, or in response to a regulatory request;
- 2.6 affiliated or unaffiliated providers of outsourced or other services, and other external service providers of Al OFC (including but not limited to printing houses, mailing houses, digital or telecommunication companies, information technology companies, data storage

and infrastructure companies, cloud providers, data processing companies and storage companies) that AI OFC engages for the purposes set out in paragraph 1.6 in the "Purpose and Use" section above; and

2.7 any actual or proposed assignee(s) of Al OFC, any actual or proposed participant(s), subparticipant(s) or transferee(s) of Al OFC's rights or obligations with respect to you and/or the MasterAccount, and/or any person(s) in whose favour Al OFC's obligations with respect to you and/or the MasterAccount are or are to be novated.

Al OFC's policy is to restrict access to Data concerning individuals to those persons who have a need to use that Data and who have been instructed to handle such information properly and observe confidentiality. Security passcodes used by clients with on-line dealing privileges are electronically encrypted.

- 3. Please note that the Data transferred outside of Hong Kong may be subject a lower level of protection and/or cease to be protected by any relevant banking secrecy, client confidentiality or data protection laws of Hong Kong.
- 4. Under the Ordinance, you have the right to:
 - 4.1 check whether AI OFC holds Data about you, and access to such Data;
 - 4.2 require AI OFC to correct any Data relating to you which is inaccurate;
- 4.3 ascertain Al OFC's policies and practices in relation to data and to be informed of the kinds of Data held by Al OFC; and
- 4.4 object to the use of your Data for direct marketing purposes and AI OFC shall not use your Data for direct marketing purposes after you communicate your objection to AI OFC.

In accordance with the terms of the Ordinance, Al OFC has the right to charge a reasonable fee for the process of any data request.

Nothing in this statement shall limit your rights under the Ordinance.

2. Cookies 類型

Cookies分為兩大類:

臨時Cookies:此Cookies屬暫時性質,會在瀏覽器環節結束時(即閣下離開網站之時)失效。透過臨時Cookies,閣下在單一瀏覽器環節瀏覽不同頁面時,網站可得悉閣下的身分,讓閣下更有效使用網站。
